WELLNESS UPDATE

- Nutrition Services Update
 - Vegetarian pizza sampling received 84% positive feedback, tracked through new Survey Stance feedback station
 - Sampling event was hosted with Deeply Rooted Vegetarian Pizza
 - Plan to add vegetarian pizza to the High School's pizza station every Monday based on feedback
 - Additional sampling events are planned to be hosted at Richfield STEM to gauge interest and expand offerings
 - Nutrition services will be working with health services to improve the process around special diet statements and to further refine and streamline the process.
 - Meal services will be offered at Richfield High School, Richfield STEM, and Richfield Middle School
 - 24/25 Procurement Review with MDE
 - No corrective actions are required this was a pilot review to prepare for 2030
 - Results highlight opportunities for growth in our procurement process
 - Working with a supplier tracker to improve procurement processes
 - Looking at updating contracts with local vendors to strengthen the supply chain
- Safe Routes to School Update
 - Awarded funding to build an adaptive bike library
 - Helpful to get closer to 100% participation in group rides
 - \circ $\;$ Projects on 70 th and 73 rd this summer are going out for bid
 - 15 events scheduled for summer programming
- Wellness Committee Update
 - Frosty four campaign from Hennepin County
 - Kickoff via email to see who is interested in participating
 - Wellness committee was on hold during the health insurance transition from Preferred One to HealthPartners
 - o Looking to add more members to the Wellness Committee

HEALTH & SAFETY UPDATE

- Radon Testing Results
 - Radon testing was completed in January 2025
 - \circ $\;$ All results were below the EPA action limit of 4 pCi/L $\;$
- Noise Monitoring
 - Noise exposure monitoring was completed in January for specific departments throughout the district including custodial, maintenance, transportation, bus mechanics music, and technical education.
 - This testing is done to determine who is required to be included on the hearing conservation management plan.

- Only one employee (music department) exceeded the permissible exposure limit (PEL), however, Richfield Public Schools is going to include all employee groups tested, with the exception of transportation, due to results close to the PEL.
- Indoor Air Quality Staff Survey
 - \circ 184 responses were collected throughout the district.
 - Responses included mice and pests and various buildings, not being able to open windows, temperature fluctuations, stained ceiling tiles, allergy concerns, and vehicle exhaust concerns in 2 rooms at Sheridan Hills.
- Indoor Air Quality Walkthrough
 - Completed in early February and we are waiting for final results for all the buildings.
- Management Team OSHA Training
 - Daniel Holcomb with IEA presented at the monthly management team training on the OSHA inspection process and what leadership should do if OSHA were to show up at their building.
 - Dan Kretsinger and Faith Breeden are working on developing standard operating procedures should OSHA arrive at any of Richfield Public Schools buildings.
- Mock OSHA Inspection
 - Working with IEA and SFM to get this scheduled for this spring.
- Tier II Reporting
 - This reporting is required by the EPA and is due annually by March 1
 - Reports any hazardous chemical stored on site in excess of 10,000 pounds with the exception of extremely hazardous chemicals.
 - Richfield Middle School stores chlorine gas for the pool which is considered to be an extremely hazardous chemical.
- MedCompass Annual Audiograms and Fit Testing
 - MedCompass arrives on site annually to complete audiograms for those on the hearing conservation plan and fit testing for those who are required to wear a respirator.
- Health & Safety Email Concerns & Safety Suggestion Form One inquiry regarding the date and times of the meetings
 - o Gabby House-Fitzgerald interest in attending meetings
 - Instructor at RCEP concerned about lead levels in drinking water

- High School Tuckpointing and Skylights
